## MESSAGE FROM THE PRESIDENT...

---

Following are my comments made to the Loudoun County Board of Supervisors on Tuesday, January 20, 2004.

Good Morning. I am Betsy Mayr, President of the League of Women Voters of Loudoun County. The League has testified many times before this Board and other governmental bodies since our founding in this county 58 years ago. However, given that many of you are new to the Board, I thought it prudent to take a moment to introduce you to what the League of Women Voters is about.

Since our inception, our mission has been to encourage citizens to become active and informed in government and in the democratic process, and to engage communities in promoting positive solutions to public policy issues through education and advocacy.

And at the core of what we do, we work to ensure that the processes necessary for real democracy are not weakened.

After a lengthy study process in June 1984, League members nationwide came to consensus on the following public policy position concerning the Citizen's Right to Know:

The League of Women Voters of the United States believes that democratic government depends upon the informed and active participation of its citizens at all levels of government. The League further believes that governmental bodies must protect the citizen's right to know by giving adequate notice of proposed actions, holding open meetings and making public records accessible.

Many actions of this Board at its January 5th meeting were executed without proper notice to the public, staff and other Board members. This is in direct opposition to everything the League has long worked for. As we have done since our founding in 1920, we will continue to speak out forcefully against any such action taken by any board that

weakens our citizens' ability to participate fully in the process of government.

The League would like to work with this Board over the next four years to ensure that the rights of the citizens of Loudoun County are protected and that the public has what they need to be active and engaged in the democratic process of government here in this county.

## FEBRUARY UNIT MEETING

---

Our monthly meeting will be in the **Thomas Balch Library** on **Monday, Feb. 23rd, 2004 at 7:00pm.** (Note date change for this month from the 3rd Mon. to the 4th Mon.) National issues are on the agenda. First will be **LWVUS Program Planning** so that our League will have a voice in the actions of the National League's Convention in June. Second will be a discussion of the LWVUS Board recommendation for the **Update of the League's position on *Selection of the President.***

Every two years state and local Leagues participate in the LWVUS Program Planning process prior to the biannual National Convention. The current Program includes topics that have been studied and discussed by Leagues across the Country with the consensus that was reached. These positions are expressed broadly so they can be applied for action not anticipated at the time of the study.

We are being asked to review the positions and recommend whether to retain as is, restudy, update or drop. (Positions are dropped when the objectives have been reached or they are no longer needed.)

The planning process is available to Leagues on-line in the Members Site on the LWVUS website at <http://www.lwv.org/leaders.html>. The website also includes **IMPACT ON ISSUES** in its entirety so those League members with access to the Internet can read the positions in depth before the meeting.

The second agenda item is discussion of whether we **concur** with the proposed update of the current Program item, *Selection of the President.* (Concurrence is the act of agreeing with a stated position. Consensus is the result of the process through which an agreement is reached)

## DO YOU CONCUR WITH THE PROPOSED NEW LWVUS POSITION ON THE SELECTION OF THE PRESIDENT?

---

The League of Women Voters has long been among the staunchest supporters for the direct election of the President. The League has testified and lobbied for legislation to amend the Constitution to replace the Electoral College with direct election. The measure, which passed the House and nearly passed the Senate in 1971, has been revived in each Congress. In 1997, the LWVUS again called for abolition of the Electoral College and for direct election of the President and Vice President in testimony before the House Subcommittee on the Constitution. The League has also supported national voting qualifications and procedures for presidential elections to ensure equity for voters from all states and to facilitate the electoral process.

The proposed updated position continues to support direct election of the President and the abolition of the Electoral College. However, in the past 30 years, much has changed in the presidential selection process and we need to define and measure our values against other factors that appear to have dramatically altered the process. Today, the process of selecting the President is dominated by questions of campaign strategy and campaign finance, the role of the parties in the primaries and caucuses leading up to the convention, the role of the media and the effect of developing technologies. If the League's concerns include encouraging the best candidates and promoting the highest participation by informed voters, we need to understand the impact of the process on those values.

Convention 2002 adopted a process to update the Selection of the President position in order to address these gaps and examine other changes that have taken place since the League's last study on this subject over 30 years ago. A task force of state and local League representatives has been working with the LWVUS Board and staff to guide the update process. **Now your input is needed!**

**Every member's opinion counts.**

A proposed new LWVUS position on the Selection of the President has been developed, and the LWVUS Board is seeking concurrence directly from individual League members. **You will find the proposed position, along with a response form, in your January/February 2004 National Voter** and online in the Position Update section of the LWVUS members' site.

**It's easy to participate. Attend the unit meeting. Bring your National Voter.**

We are being asked whether we strongly support, accept, or do not accept the proposed position. After you have studied the position and formed your opinion, send in your concurrence response to the LWVUS office, preferably online in the Position Update section of the LWVUS members' site (<http://www.lwv.org/concurrence/>). Or you may respond by mail.

Postmark deadline is March 1, 2004. Online deadline is March 4, 2004.
