## LWVUS Convention 2008

Convention was WONDERFUL! Lots of fun, lots of people, and lots of learning. Barbara Roberts, the first woman governor of Oregon (1991-1994) gave a delightful and interesting opening address.

I helped present the caucus on Ranked Choice Voting. We're trying to encourage studies by state and local leagues, so I plan to follow up by trying for a Virginia study on the subject.

I attended Olga's [President of the LWVVA] caucus on the proposed Redistricting concurrence, plus caucuses on NPV (National Popular Vote for President), Election Integrity, and Public Financing Campaign Reform, plus workshops on Growing Membership and Media Outreach Tactics. I also attended part of the caucus on the Massachusetts Healthcare Reform...they seem to have gone the wrong way by simply adding another layer of bureaucracy and are already very in the red financially.

John Kitzhaber, another ex-Governor of Oregon (1995-2002), gave a Health Care address (he is a doctor as well as a politician). LWVUS is hoping to get permission to place

the information on its website. Other presentations included a Climate Change panel and a speech by a representative of the Institute for the Advancement of the American Legal System.

### CONVENTION BUSINESS

**Convention Rules:** A new rule was created due to complaints at the previous two conventions regarding last minute resolutions that everyone had to vote on without knowing much about them. Under the new rule, resolutions for this convention were due 30 days prior and had to meet criteria to be "approved" by a committee. The approval was just informative. The delegates had a chance to decide for themselves which resolutions to address at Convention and which to skip over. The rule was amended to remove most of the restrictive criteria and then passed.

I learned there is a growing concern about using resolutions and motions to "bypass" our concurrence process and amend Program without studies. The convention rule 10.1 was an attempt to try out something that, if successful, could be proposed as a Bylaws change later. However, it had the

unfortunate illogical effect of creating a committee PRIOR to the convention, but Convention Rules are only adopted AT convention and in effect DURING convention. So the so-called rule was “kinda sorta” in effect before its official adoption. Obviously, this caused quite a stir. Fortunately, a compromise was reached - a resolution was passed to work on a “resolution procedure” in time for discussion at Council 2009 as a possible rule for Convention 2010.

**Bylaws:** Bylaws amendments that passed included: authorization for electronic board meetings; addition of one convention delegate per each 100 members-at-large; clarifies that the national board may propose changes of national positions by concurrence, with the same required notifications to all leagues; reduced the Nominating Committee from seven to five members; clarifications to the call to council. All other Bylaws proposals were defeated, including the proposal to elect the Board by the membership rather than at Convention.

**Resolutions passed:** LWVUS has been requested to redesign fundraising requests so they cannot be misconstrued as membership recruitment or dues notices; the “resolution procedure” mentioned above. The redistricting concurrence proposed by VA and OR was defeated.

The Principles were amended with the addition of a sentence mentioning a balance among all three branches of government: legislative, executive, and judicial (up to now, judicial has not been mentioned anywhere).

**Other motions:** The Board recommended Health Care program was approved, as was a global climate change Education and Advocacy Campaign. The non-recommended study item on NPV was approved. (I went to the Convention feeling neutral on NPV, but the caucus I attended convinced me this is a worthwhile study, especially since New York has already nearly completed it, and was then told it was a National issue, and they couldn't adopt a position. Some of the points raised: most of the Presidential campaign time and money are spent in the few “battleground” states, contributing to voter apathy in the remaining states; the battleground states have a 10% higher voter turnout; discussion of issues is distorted by what is important to the battleground states.)

**Budget:** PMP of \$28 for 2008-9 and PMP of \$29.20 for 2009-10 were approved.

**Board:** No nominations were made from the floor. The proposed slate was approved unanimously, which includes the LWVUS' first male director.

**Guidance To The Board:** The first full day, a caucus was announced for those interested in the Presidential Debates. About 20 of us got together and decided it's high time for the League to get back into running them if possible, so we determined to offer “Guidance” in the form of strongly urging the LWVUS to run a debate this year. It's not likely to happen, but it should at least pave the way towards an effort in 2012, and may result in some publicity this year. I suggested, to put some weight behind the Guidance, that we circulate a petition among the Delegates and ask them to sign to show support. So Barbara DeWilde from PA, the leader of this effort, created a petition and those of us on the “Steering Committee” passed it around the remainder of the Convention, collecting 500+ signatures from the 600+ delegates attending. There was a lot of excitement generated, and someone heard an announcement on NPR that the petition was being circulated at out Convention! League President Mary Wilson announced, even before the Guidance portion of the agenda, that the Board would definitely follow up on this.

**Other Guidance To The Board:** Provide a “Young Leaders” award; provide financial assistance, if needed, to Leagues receiving awards so they can attend the Convention to receive the award; webcast the next Convention; be sure that speakers engaged for the Convention are asked to join the League; create a new membership category in the Bylaws for HOAs and other organizations; try for a clause in the contracts for conventions that will protect us in case of labor disputes at the chosen site or weather issues that affect transportation; investigate alternatives to PMP; create procedures for state and local leagues so they can lobby their federal delegation or contact federal agencies without “waiting on” National.

I was very impressed at how people could work towards solutions. I think the concurrence process permeates the organization. Or maybe it's just because most of us are women, and we try to lessen conflict. President Mary Wilson is FANTASTIC...she runs a really mean convention with grace and a very quiet voice...she is awesome at sorting out issues and proposing ways of dealing that are fair and efficient.

## In Passing

Alexandria League member **Ellen Pickering** died in April. She served on the Alexandria City Council and was noted for her environmental activism. She battled developers who wanted to destroy Alexandria' historic waterfront. She organized Save the GW Memorial Parkway and was instrumental in the National Park Service approving the Mount Vernon biking and hiking trail.

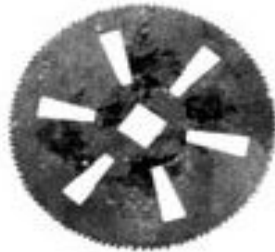
**Elizabeth Masters**, a long-time Loudoun League member, died May 2. She joined League in the late 1960s and served as Secretary in the early 1970s. Jean Sagan, who was President during that time, said “I am greatly saddened. She was my mentor and a lifesaver.” Ms. Masters was a Loudoun Woman of the Year. Her many activities included the Loudoun Valley Community Center, Loudoun Food Closet, and Upper Loudoun Little League.

## Who Invented the Circular Saw? A Woman of Course!

Tabitha Babbitt, a Massachusetts Shaker, invented the circular saw in 1813. She was working in a Shaker spinning house when she realized that the wheel could be applied to cutting logs. At the time, two-man pit saws were used in saw mills. Babbitt made a toothed disk, put it on the spindle of her spinning wheel, and discovered that her rotating circular blade could saw wood more efficiently.

Babbitt's other inventions included a new method of making false teeth, an improved spinning wheel head, and cut (as opposed to individually forged) nails. This latter invention enabled mass production of nails.

However, because of Babbitt's Shaker beliefs, she did not obtain patents for her inventions.



## 1943 Guide to Hiring Women

Excerpts from the July 1943 *Transportation Magazine*:

#1 Pick young married women. They usually have more of a sense of responsibility than their unmarried sisters, and they are less likely to be flirtatious.

#2 When you have to use older women, try to get ones who have worked outside the home at some time in their lives. Older women who have never contracted the public have a hard time adapting themselves and are inclined to be cantankerous and fussy.

#3 General experience indicates that "husky" girls - those a little on the heavy side - are more even-tempered and efficient than their underweight sisters.

#4 Retain a physician to give each woman you hire a special physical examination - one covering female conditions. This will reveal whether the employee-to-be has any female weaknesses that would make her mentally or physically unfit for the job.

#5 Be reasonable considerate when using strong language around women. Even though a girl's husband or father may swear vociferously, she'll grow to dislike a place of business where she hears too much of this.
