## The Red Hat Voters

In July I had the pleasure of speaking with residents at Mirror Ridge at Community Village in Sterling to provide information on voter registration, the November ballot, and absentee ballots. I knew a Red Hat luncheon would be fun, but I didn't realize how much fun until they put a huge red hat on me. These ladies are smart - in July they wanted to know about the November election. Most people wait until late October to focus on issues. The 13 women and two honorary male members were familiar with the League of Women Voters and our services. Many were or had been members of the Fairfax or Maryland Leagues and had worked as Officers of Election in their polling places.

I distributed the Constitutional Amendment language and US Senate and 10<sup>th</sup> Congressional District candidate information.

They had questions about registering to vote in Loudoun County and absentee voting and were happy to know the ballot could be sent to them.

The big question was, "What is happening to our beautiful county with all the development? How can we stop growth?" The best answer is to know who you are voting for and whether the candidates will truly fight this battle once the elections are over. Their observation was that it is hard to determine who is right for office since the candidates sound the same. I gave them contact information for each candidate and encouraged them to do their research and ask questions. I was honored to speak to this well-informed group.

### **Mary Blevins Remembered**

Mary Blevins, 79, a Sterling resident and past President of the LWV Loudoun County, passed away June 19. In a letter to the editor of the *Loudoun Times-Mirror*, former Senator Charles Waddell recalled her activism in the 1960s. Mrs. Blevins was responsible for getting a deputy registrar appointed by the Loudoun County Electoral Board and once registered 750 voters in one evening.
