League Goes All Out on Voter Registration

The LWC of Loudoun County has been extremely busy with voter registration this year.

We went into 10 high schools, registering more than 2,000 high school seniors.

On May 24, we conducted voter registration at Woodgrove High School in Purcellville. Congressman Frank Wolf (R-10th District) addressed the students. His opponent, Kristen Cabral was invited. League member Jean Brown spoke to the students on the importance of voting.

We also spent two weekends in August at the Leesburg Corner Outlet Mall registering voters, explaining how to apply for an absentee ballot, and accepting forms for address changes.

Voter registration was conducted at Spring Arbor Assisted Living and Cascades Senior Center.

League members helped the Registrar's office October 12-15 in a voter registration blitz at libraries in Leesburg, Ashburn, Purcellville, and Cascades.

Ask anyone involved in the election process and they will tell you that it's been a long year - and an even longer past few months. With elections come the opportunity for the League of Women Voters of Loudoun County to conduct voter registration, candidate fora, and educational outreach. Despite the fact that very few League members are active participants, a few dedicated members have been steadfast in doing all we can to participate in the process. In October alone, here's what the few accomplished:

- Served as extensions to the Registrar's office and registered voters at four libraries the October 13-15, the final days before the registration deadline.
- Served as workers in the Live Broadcast State debate in Richmond for the Virginia Senate candidates on October 8.
- Co-hosted with Delta Sigma Theta, Inc Loudoun Alumnae Chapter and Loudoun Education Association an

informational women's forum "Why Women Vote" on October 22.

- Unfortunately we cancelled the Meet the Town of Leesburg Candidates forum at Ida Lee Recreation Center on October 29, co-hosted with *Leesburg Today*.

In past Letters from the Presidents, we have tried to rally League members to help us when we host events, educate the public on issues, and conduct voter registration. We need all of our members to rise to the challenge. Because we are women (that is, most of us are) we are busy, but in order for our League to continue to carry out its important work of high school voter registration, candidate fora, and non-partisan discussions of issues that affect our daily lives, we need your help. Every year, another high school is opened, requiring more volunteers so we can go to all 11 high schools in Loudoun County. Last year we registered more than 2,000 high school seniors to vote.

Next year, the General

Assembly will once again introduce legislation that will affect our rights as women. Our voices must be heard – and numbers speak volumes. We can't fight alone. We can't advocate alone. We can't educate alone.

We need your help. Whether it's making phone calls, helping set up at an event, or spending one day to register the high school seniors, there is something for everyone. We need you to help us continue the momentum.

Many of you receiving this newsletter have been members for years, but have not renewed your membership in the last year or two. You will be receiving a call asking you to send in your dues. We need your monetary support as well.

There are only so many hours in the day, but we are asking for just a few hours of your time. The few active members are getting tired. We can't do everything but remember - if you can't help us, please don't criticize us, we are doing the best we can.

Condo Elections

The League of Women Voters of Loudoun County assisted with several condo elections this fall. The donations received from these efforts help fund projects such as forums,

debates, panel discussions, and ongoing voter registration.

League members secure and count ballots. This year we offered condos the use of a secure ballot

“Why Women Vote” Panel



The League partnered with Delta Sigma Theta Sorority Loudoun County Alumnae Chapter and the Loudoun Education Association on a town hall-style forum on “Issues and Concerns That Motivate Women Voters.” The forum was October 22 at Cascades Library in Sterling. The program included:

- Jeff Dunn, who spoke on

testing and measurement of student progress. He noted that education was largely absent from the presidential campaigns.

- Phyllis Randall, speaking on education, noted that graduation rates tend to follow economics. She said that homeless students have the ability to succeed but may show little

- Dr. Angela Bess discussed healthcare and the differences in

Obama’s and Romney’s plans for healthcare and Medicare. She reminded the audience that women make most of the health decisions.

- League member Angela Mitchell spoke about being a woman-owned small business. She observed that it is difficult to find qualified employees with the right skills and attitude.
- Jennifer Wexton, an attorney, noted that one effect of the economy is that the divorce rate is lower.

The League and Deltas hope to continue the discussion in future meetings.
