Election 2016 Deadlines. Last day to register to vote is October 17; Absentee Voting Starts September 23; Deadline to request a ballot by mail is November 1, 2016 and Deadline to Vote in Person Absentee is November 5, 2016. Don't miss your voting opportunity; please keep these deadlines in mind.

Fall Election Deadlines

Monday, October 17 – deadline to register to vote

Friday, September 23 – absentee voting starts

Tuesday, November 1— deadline to request a ballot by mail

Saturday, November 5 – deadline to vote in person absentee

Election Day – Tuesday, November 8, 2016

Candidate Forums. LWV-LC is planning three public candidate “meet and greet” forums for this fall. All will be free and open to the public, and will be moderated by local media personality.

- **Thursday, September 15 - Leesburg Town Mayoral Candidates at Rust Library, 7:00 – 8:30 p.m.** Three candidates are running for a term of two years. David Butler (incumbent), Kelly Burk (D), and Kevin Wright (R).
- **Thursday, September 22 – Leesburg Town Council Candidates at Rust Library, 7:00-8:30 p.m.** Six candidates are running for two-year terms on the Council: Ron Campbell, Thomas Dunn (incumbent), Katie Hammler (incumbent), John Hilton, Evan Macbeth, Gwen Pangle
- **Tuesday, October 18 – 10th District Congressional Candidate Forum – Northern Virginia Community College, Loudoun Campus, HEC Building, 7 – 8:30 p.m.** Meet and greet the two candidates running for this seat on the U.S. House of Representative: LuAnn Bennett (D) and Barbara Comstock (R, incumbent). Voters can meet the candidates and ask them questions about issues in your communities.

On the Ballot – Voting Issues

Two Proposed Constitutional Amendments will be voted on in the November 8 Election.

This is the second of the two consecutive years these amendment have been on the ballot before being instituted. For full text on these constitutional amendments, [click here](#).

Ballot Question #1 - Article I. Bill of Rights. Section 11-A. Right to work.

Question: Should Article I of the Constitution of Virginia be amended to prohibit any agreement or combination between an employer and a labor union or labor organization whereby (i) nonmembers of the union or organization are denied the right to work for the

employer, (ii) membership to the union or organization is made a condition of employment or continuation of employment by such employer, or (iii) the union or organization acquires an employment monopoly in any such enterprise?

Explanation

Present Law

Currently, Virginia's right to work law, § 40.1-59 of the Code of Virginia, provides that any agreement or combination between an employer and a labor union or labor organization whereby (i) nonmembers of the union or organization are denied the right to work for the employer, (ii) membership in the union or organization is made a condition of employment or continuation of employment by such employer, or (iii) the union or organization acquires an employment monopoly in any such enterprise is against public policy and illegal. This has been the law and the declared public policy of the Commonwealth since 1947.

Proposed Amendment

The proposed amendment places the provisions of Virginia's right to work law into the Constitution of Virginia. While Virginia law may be amended by any future General Assembly, a constitutional prohibition can only be changed by a future constitutional amendment approved by the voters.

Ballot Question #2 - *Article X. Taxation and Finance. Section 6-B. Property tax exemptions for spouses of certain emergency services providers.*

Question: Shall the Constitution of Virginia be amended to allow the General Assembly to provide an option to the localities to exempt from taxation the real property of the surviving spouse of any law-enforcement officer, firefighter, search and rescue personnel, or emergency medical services personnel who was killed in the line of duty, where the surviving spouse occupies the real property as his or her principal place of residence and has not remarried?

Explanation

Present Law

Article X, Section 6-A of the Constitution of Virginia now requires the General Assembly to exempt from taxation the real property, including the joint real property of husband and wife, of any veteran with a 100 percent service-connected, permanent, and total disability, as determined by the U.S. Department of Veterans Affairs, and the real property of the surviving spouse of an eligible veteran. This exemption from taxation applies to the principal place of residence of the eligible veteran or of the surviving spouse of an eligible veteran. The exemption ceases if the surviving spouse remarries.

Article X, Section 6-A of the Constitution of Virginia also authorizes the General Assembly to exempt from taxation the real property of the surviving spouse of any member of the Armed Forces of the United States who was killed in action, as determined by the U.S. Department of Defense. This exemption from taxation applies to the surviving spouse's principal place of residence, and the exemption ceases if the surviving spouse remarries.

Proposed Amendment

The proposed constitutional amendment authorizes the General Assembly to enact a law that would allow a locality to exempt from taxation the real property of the surviving spouse of any law-enforcement officer, firefighter, search and rescue personnel, or emergency medical services personnel who is killed in the line of duty. The exemption from taxation would cease if the surviving spouse remarries.

The exemption would apply regardless of whether the spouse was killed in the line of duty prior to the effective date of this amendment but would apply only to those real property taxes to be paid on or after the effective date of this amendment. The exemption from taxation would apply to the surviving spouse's principal place of residence, even if he or she moves to a new principal place of residence. The exemption would not require the surviving spouse to have been residing in the Commonwealth at the time his or her spouse was killed in the line of duty.

The proposed constitutional amendment authorizes the General Assembly to prescribe additional restrictions and conditions on the exemption from taxation if enacting such a law.
